At the outset Dr. RaghunathNaik, Chief District Medical & Public Health Officer, Jagatsinghpurwelcomed to all members and chairperson to the meeting.

The Collector & DM - Cum-Chairperson of DLMC reviewed the last meeting proceeding held on dt.28,03,2024. Dr. SatrughnaDash, DistrictPublic Health Officer, Jagatsinghpur read out the point wise compliance of the last meeting proceeding for information of all esteemed members of the committee.

Then discussion was done on Agenda points and decision taken there off as follows:-

Regarding Lifting of General Waste from DHH, Jagatsinghpur:

Collector & DM suggested to Executive Officer Municipality to outsource private agency for lifting of general waste through tender process. So that the issues pertaining lifting of general waste will be resolved. An exclusive team will work for DHH, Jagatsinghpur for lifting of General Waste.

Responsibility: -Executive Officer, Municipality, Jagatsinghpur

> Construction of Storage and Equipment rooms of all PHCs, CHCs and DHH with three-phaseelectrification.

Status regarding completion of storage cum BMW equipment room in PHC & CHC of DHH Jagatsinghpur.

All are completed except Tarasahi PHC, Polasol PHC, new building will be constructed.

Responsibility: -AE, NHM/DPM, NHM/DPHO, Jagatsinghpur

Barcoding system at DHH, CHC & PHCs

Implementation of the Bar-Coding system up to PHCs Level.

Installation of equipment's in all CHCs and PHCs are completed by MIndtrack Agency

First round training completed and reorientation of BMWM Handlers required for fully functionalization of Bar-coding system. For this letter to be done to Mindtrack agency.

> Establishment of STP & ETP at DHH Jagatsinghpur

As regards to expansion of DHH to facilitate construction of different projects including site for establishment of ETP & STP. The collector & DM directed Executive Engineer R&B to prepare RFP in consultation with district Health Administration. Assistant engineer, NHM to submit the plan before R&B for facilitation of the project.

> Authorization of CTO to 30 bedded CHCs

As regards to authorization of CTO to 30-bedded CHCs the committee suggested that the Superintendent of concern CHCs should coordinate with Regional Officer SPCB to facilitate the process of authorization by submitting undertaking, as Construction of STP & ETP for 30-bedded hospital will be taken up by state in phased manner by 2027-28 as per letter no. 5213 dt. 11.08.2023 of Director of Public Health Department of H & FW Odisha.
